Our Terms

I have been blogging since 2004, professionally since 2012. I've been around a long, long time – and do not have plans of going anywhere any time soon!

Below you will find our terms of use for working with Life in a House. These items are non-negotiable.

Terms of Use for Life in a House

- We are located in Virginia, United States and all times are Eastern Standard Time. If you are unsure of what time it is in our area, we are on the same time schedule as New York, New York

- **Invoices are due upon receipt** – failure to pay within 2 days is a \$20 late fee. Failure to pay within 4 days is a \$40 late fee. Failure to pay within 6 days is a \$60 late fee.
- **We include weekends and holidays**; for example – if you submit an article for publication on a Friday and we send you an invoice at 7:45 AM Eastern Standard Friday morning, your payment would be due by 7:45 AM Eastern Standard Sunday morning or the first late fee would be added.
- Late fees are as follows:
 - If not paid within **2 days** - \$20 late fee added
 - If still not paid within **4 days** - \$40 late fee added
 - If still not paid within **6 days** - \$60 late fee added
- **ALL PAYMENTS ARE DUE PRIOR TO PUBLICATION** – This may seem odd to you; but we DO provide a preview link of your article of exactly how it will appear on www.lifeinahouse.net once it is published for your review.
- **We WILL NOT remove late fees.** We inform you in the email that is sent with a link to your article and to the invoice what our policy is and it is readily available for anyone to download and read here.
- I cannot stress the above about invoices and late fees enough. In the past, we published articles and would wait to receive our payment ... unfortunately, the world is full of dishonorable people who refused to pay for their invoices so we simply ceased waiting and require payment in advance. We have a list of blacklisted contributors and people who do not honor their word for you to review.
